- The bidder must identify the telephone number they wish to be called at on the day of the auction. **Auction day #** _____.
- The bidder will be telephoned a few minutes before the item is to be auctioned, to ensure a connection can be established from the auction.
- Moss Auction Team limits only three absentee phone bidders at a time per one item being auctioned.
- A starting bid and a maximum bid must be submitted on each item.
- The absentee bidder form must be signed and dated by the absentee bidder.
- The absentee bidder must provide an irrevocable letter of credit from the absentee bidder's financial institution in the amount equal to the maximum bids authorized.
- The absentee bidder form must be completed and received by the Moss Auction Team at least two business days prior to the auction start time.
- The irrevocable letter of credit must be acceptable to the auctioneer in the auctioneer's sole discretion.
- Moss Auction Team will confirm acceptance or nonacceptance of the absentee bidder form to the bidder prior to the date of the auction.
- All absentee bidders are subject to the same terms and requirements as present bidders participating in the live auction, including the term announcements on sale day take precedence over printed material.
- The successful absentee bidder agrees to pay for items purchased in the full amount no later than three business days after the date of the auction.
- All absentee bidders shall rely entirely on their own inspection and information of items being offered for sale by auction.
- All information given to Moss Auction Team by the absentee bidder will remain confidential.
- The auctioneers agree to follow the absentee bidder's instructions and authorizations in an ethical and professional manner and to bid in increments accordingly as seen fit by the auctioneers.
- Bids made by the auctioneers on behalf of the absentee bidder will have the same legal effect as if made by the bidder personally at the live auction.
- Neither auctioneers nor owner of items in the auction guarantee condition of merchandise in this sale.
- All merchandise will be sold "as is, where is".
